

Subject:- Grant of permission to purchase agricultural land
S.No. 232 of Haveri, U/s 63 of the B.T. and A.L. Act.

Preamble:

The Chairman, Board of Management, K.L.E. Society, Belgaum, requested, by an application dt. 8-5-1964, for permission to purchase agricultural land S.No. 232 of Haveri, as the land is required for the benefit of Educational institutions. Since the land was an Inam of class VI-B (Patilki-Inam), permission was not granted and the Chairman was suitably informed in the matter on 24-5-1964. The holder of the land, on payment of necessary bazarana amount has subsequently obtained the land on lod-tenure, as per Deputy Commissioner's order No. WCNSR-1905 dated 22-2-1965. The Chairman of the K.L.E. Society by his letter No.32(2)/266 dated 1-5-1965 has now requested that in view of the above changed position necessary permission sought for may be granted. The Tahasildar Haveri has reported that there is no objection to grant permission U/s 63 of the B.T. and A.L. Act in this case. The Society is registered under the Bombay Public Trust Act, and also under the Societies Registration Act.

Order:

Permission U/s 63 of the B.T. and A.L. Act, r.w. rule 36(1)(b) of the Rules, thereunder is hereby granted to the Chairman, Board of Management, K.L.E. Society, Belgaum to purchase agricultural land S.No. 232 of Haveri taluka Haveri subject to the following conditions.

(1) ~~The~~ The land S.No. 232 of Haveri shall be used only for the benefit of the Educational Institutions, run by the K.L.E. Society, Belgaum, and that,

(2) Such use shall commence within one year from the date of taking over possession of the land by the said society.

For breach of any of the above conditions, this permission shall be deemed to have been cancelled and the purchase shall be deemed to have been made without previous sanction of the Deputy Commissioner and further the land in question will be liable for being granted by the Deputy Commissioner subject to all or any of the conditions afore-mentioned, and also any other condition which Government in public interest may choose to impose.

This permission is further subject to other provisions of the Tenancy Act and also subject to the provisions of any other law for the time being in force and for any other directions which Govt. or the Deputy Commissioner, may impose in public interest at any time.
