the name of institution and regional Director of the concerned Regional Committee as per clause 7(16) of NCTE Regulations 2014.

4. Due to less built up area, the institution be given Lol for only one unit of ITEP. The institution be directed to submit reply to Lol for one unit of programme opted by it (B.A B.Ed or B.Sc. B.Ed)

*5. Further, admissions shall not be made until Recognition Order under Regulations 7(16) of the NCTE (Recognition Norms and Procedure) Regulations, 2014 is issued by the **Southern Regional Committee**, NCTE and thereafter obtaining the affiliation from the concerned affiliating body.*
